Repeal & Consolidation By-Law

All By-Laws of the Town of Mulgrave heretofore in effect are repealed except for the following by-laws:

- 1.) Closing Public Streets by-Law (dated July 11, 1973, and bearing By-Law # 18);
- 2.) Closing Public Street By-Law (dated May 10, 1972, and approved by the Minister of Municipal Affairs on July 25, 1972);
- 3.) Town *Seal By-Law (dated May 19, 1983);
- 4.) Boundaries By-Law (Boundaries of the Town of Mulgrave as amended by Order-in-Council of April 29, 1927);
- 5.) Tree committee By-Law (dated December 9, 1982 and approved by the Minister of Municipal Affairs on December 23, 1982);
- 6.) Anti-Litter By-Law (dated December 9, 1982 and approved by the Minister of Municipal Affairs on December April 16, 1971);
- 7.) Cost of Advertising By-Law (dated April 6, 1971, approved by the Minister of Municipal Affairs on April 16, 1971);
- 8.) Building By-Law (dated March 28, 1977 and approved by the Minister of Municipal Affairs on April 7, 1977);
- 9.) Committees By-Law (dated January 15, 1979, approved by the Minister of Municipal Affairs on February 5, 1979);
- 10.) Taxi By-Law (dated June 7, 1984, approved by the Minister of Municipal Affairs on July 6, 1984);
- 11.) Peace & Good Order By-Law (dated June 7, 1984, and approved by the Minister of Municipal Affairs on July 6, 1984);
