



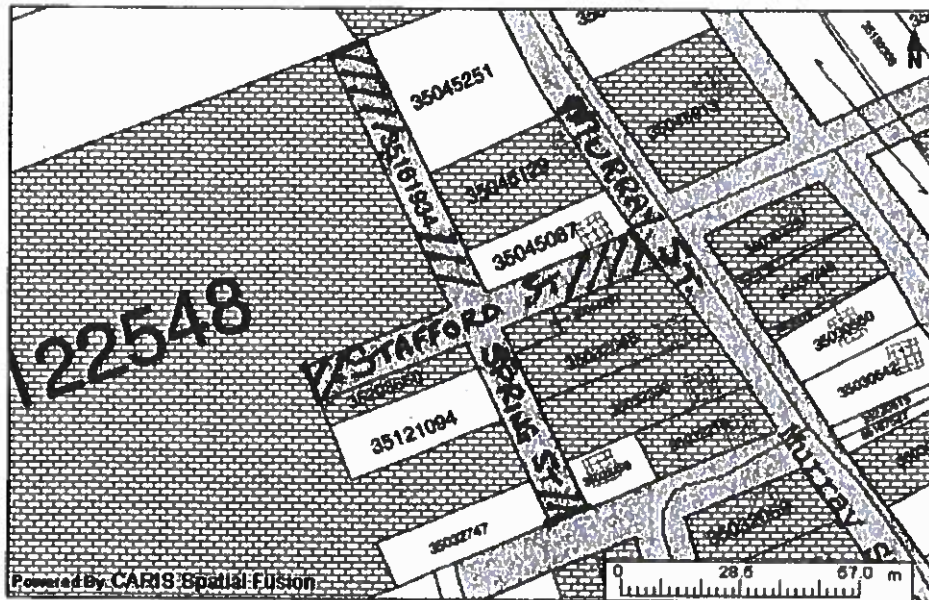

A Public Hearing will be held for the purpose of receiving the written or oral comments of those persons who may be in favour of or opposed to the proposed policy.

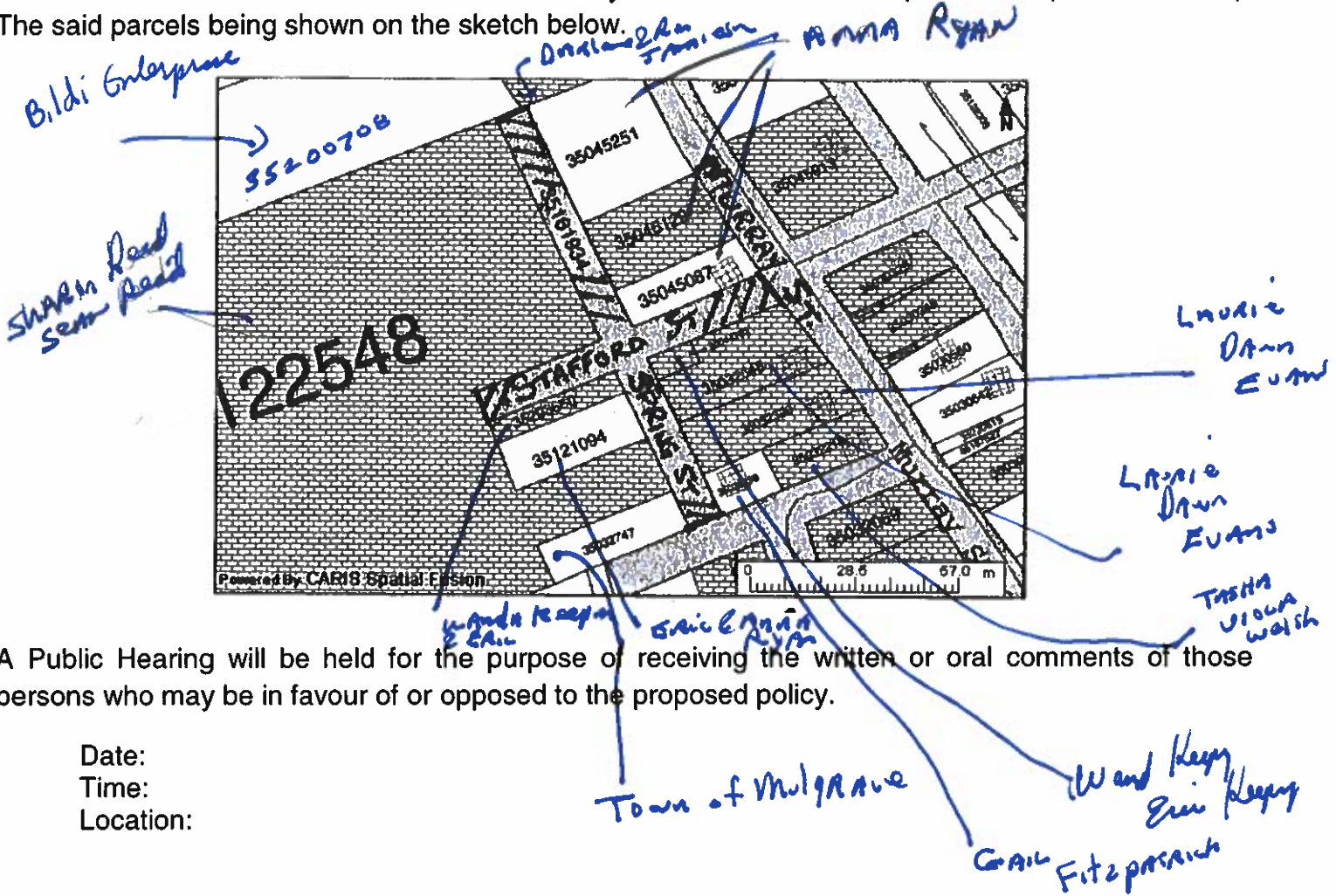


Re Notice of Public Hearing Proposed Street Closures-unopened portions of Stafford Street and Spring Street
