

**By-law No. 1**  
**Town of Mulgrave**  
**Repeal and Consolidation By-law**

BE IT ENACTED by the Council of the Town of Mulgrave, under the authority of the *Municipal Government Act*, S.N.S., Chapter 18 as amended, as follows:
